
I have grown so much from this place.

Step 1. Consult your lawyer and designate the **YWCA Saskatoon Inc.** (our legal name) as a beneficiary of your estate plans.

Step 2. Please let us know of your intentions by downloading and sending us the **Legacy Gift Notification Form**. Most information on the form is optional and all will be kept in strictest confidence.

Ways To Leave a Legacy Gift

Gift in will

By far the simplest way to leave a gift is to include the **YWCA Saskatoon Inc.** (our legal name) as a beneficiary of your will. A gift in your will ensures your legacy lives on and by doing this you can also reduce tax payable by your estate. We can provide sample will clauses for your convenience.

Gift of shares or mutual funds

Transferring publicly traded securities or mutual funds from your brokerage account to the **YWCA Saskatoon Inc.** eliminates your capital gains tax. This generates greater tax saving than if you sold the securities and then donated the cash proceeds.

Gift of life insurance

Consider transferring ownership of an existing life insurance policy that is no longer required for your family's financial security to the YWCA. Donating an existing life insurance policy involves designating the **YWCA Saskatoon Inc.** as the owner and beneficiary of an existing policy that you no longer need. You can also purchase a new policy and donate the policy to the YWCA by making the **YWCA Saskatoon Inc.** as the owner and beneficiary. You will benefit from receiving a charitable tax receipt for the value of the policy.

If you wish to remain the owner of the policy, your estate will receive a charitable tax receipt by naming the **YWCA Saskatoon Inc.** the beneficiary of the policy.

Gift of a RRSP, RRIF, TFSA

You can name the **YWCA Saskatoon Inc.** as the beneficiary of your RRSP, RRIF, or TFSA. Your estate will receive a charitable donation receipt for the funds received when you name the **YWCA Saskatoon Inc.** as the direct beneficiary of a RRSP, RRIF or TFSA.

Setting up such a donation is as simple as asking your financial advisor or financial institution to change the beneficiary to the **YWCA Saskatoon Inc.**

Our Commitment To You

Our **10 promises** to those who leave a legacy gift to the YWCA in your will.

We know this is a big decision to make, which is why we want you to feel comfortable about considering it.

These are our commitments to you:

- 1 We will always respect your privacy. We recognize and appreciate that your will is completely personal to you.
- **2** We also realize that your family and loved ones will always come first.
- **3** Because we are committed to making a difference that will benefit women and girls, we always encourage people to leave something to the YWCA, but we recognize that it's your decision and you need to make it in your own time.
- 4 You can tell us that you left a gift if you want to, and we'd love to hear, but you don't need to tell us and we won't keep asking you.
- 5 If you do choose to tell us, we will give you the choice about how we talk to you in the future about our work at the YWCA.
- 6 We will give you and your family as much choice as we can about how and where your gift will be used to benefit women and girls.
- 7 We will use your gift carefully and cost-effectively so it has the greatest impact in our work and for those we serve.
- 8 We will give you the opportunity to be connected with the work we do that is made possible by gifts like yours.
- **9** At any time in the future you have the absolute right to change your mind about a gift in your will to the YWCA.
- **10** We will handle whatever gift you leave us efficiently and with care, sensitivity and respect.

The YWCA encourages you to have open conversations with your family about your decision and to always seek the advice of a financial advisor and lawyer.
